She will demonstrate how she uses scissors, gel medium, and colored or patterned papers to "paint" with. This medium is immediate. If a sequence of colors or patterns is not working, another can instantly be inserted. The artist also is able to translate her creations easily into acrylics.

Robinson graduated from the Massachusetts College of Art in Boston with a degree in *Art Education and Painting*. She's exhibited among other places at the Bernard Toale Gallery in Boston, the Arts League of Lowell and was a prize winner in the Chelmsford Art Society Annual Show. She is presently the "Exhibits Chairman" in the Chelmsford Art Society and is co-leading a Library Workshop in May.

Debra will bring some materials, and everyone attending is encouraged to bring additional materials for themselves as well.
